2018 Elections

During 2018 year there are three guaranteed elections:

April 3, 2018	Spring Election
August 14, 2018	Partisan Primary
November 6, 2018	Fall General Election

If the April election needs a primary it would be February 20, 2018. We will not know until the second week of January if there will be a February primary.

Voter maintenance

During June of 2017 the Wisconsin Elections Commission sent postcards to all registered voters in the State of Wisconsin that had not voted in the last four years. If you received one of those postcards and did not sign it and return it to the Clerk, you were removed from the voter list. You will be required to reregister the next time you come in to vote. Keep in mind that if you have been voting in the last four years you would not have received a postcard.

Property Taxes 101 by Nicole Lipske, Treasurer and Julie Kriewaldt, Clerk

It has been a couple of years since this article was in the newsletter so we thought it was time to update it and rerun the article. The Property Tax season is coming!

Tax bill preparation timeline: The budget process for all taxation districts starts early in the fall. The Town’s levy is set at the budget hearing the third Monday in November each year. The clerk also has to receive all the levies from the State, County, and school districts before she can submit it to the County Treasurer to prepare the tax bills. That information is generally received and taken to the County Treasurer the week after Thanksgiving. Washington County prints all tax bills for the County which has 33 municipalities. When the tax bills are ready, usually around December 10th, the Erin Treasurer picks them up, stuffs the envelopes and mails them out. There are approximately 2,000 tax bills. By state statute, the tax bills must be mailed by the 3rd Monday in December.

Changes in mailing address: For the snowbirds, if your mailing address has or will

change, please notify the Erin Treasurer before December 1st so the tax bill can be mailed to your location. Let the Treasurer know if this is for one year only or a permanent change.

Paying your taxes: The tax bill envelope will contain the following: your tax bill, a payment envelope, a letter from the Town of Erin Treasurer, and on the reverse side a dog license application (you can copy this if needed for additional dogs). You can pay your taxes and submit your dog license application at the same time. Please write out a separate check for the dog license application(s). In the letter, the Erin Treasurer will let you know when she has set up office hours to collect taxes. If you do not want to wait in a long line, they can be mailed to the Town Hall, attn.: Treasurer (**checks made out to Town of Erin**).

Refunds & receipts: If your taxes are paid in full and you are due a refund for over payment, they are processed 20 days after the Treasurer has cashed your check not 20 days from when the check was received. If you want a receipt for your tax payment, please include a self-addressed, stamped envelope. We do not automatically send out receipts. We also do not send out reminders for a second payment due in July.

Payments by credit card: Payments by credit card can be made. The fees can be quite large and are not controlled or collected by the Town of Erin. If the payment is made by debit card or e-check, the fee is minimal. It will take a couple days before the Town is notified of the payment.

Payment timeline: Either the first installment or full payment is due by January 31st each year. You make that payment out to “Town of Erin”. If you make the first installment by January 31, then the 2nd payment is made out to Washington County Treasurer and mailed to 432 E. Washington Street, West Bend, WI 53095. The second payment is due to Washington County by July 31st each year. If it is past January 31st and you did not make a payment, contact the Washington County Treasurer as that is where your payment will go.

Washington County Treasurer Tax website: The County

website does not get updated with tax payment information until the end of February. If you or your bank views the website between December 5th and February 28th each year, it will look like your taxes are delinquent when they are not. This is because the tax software used at the municipalities is not directly linked to the County site (there will be a change in 2019). Every February, the municipality emails the information to the County Treasurer. They upload it and do a series of checks and balances before it is released for the public to see.

Town Chairman Report by Dennis Kenealy

The U.S Open was here and gone. After all the years of work and anticipation it seemed like it was over in a day. We experienced no problems and as a Town made some money on rental of the property. All our property was returned to us in excellent condition so the Town had no monetary loss.

We are now entering our new budget cycle and the Executive Committee will be meeting in October to go over the initial budget after which it will be presented to the citizens and Town Board for their approvals. We as a Town are in a good financial position and I am not aware of any large expenses other than the normal operating expenses.

The Town has started the process of ending our rental of the old Lucy's property and the future demolition of the house. It is in need of repairs and is not a feasible situation for the Town to be acting as a landlord.

Plan Commission by Dennis Kenealy

The Plan Commission is looking at proposals for a Town Zoning Administrator. It is something we do on occasion to judge whether we are adequately served at a fair price and will be considered in the coming months.

The Commission is involved in reviewing requests under the Town's recently adopted Agritourism\Event Barns ordinance. That is a very detailed process as there are numerous guidelines to follow and conditions to be met.

success. We had some storms move in, and the course was evacuated and play was delayed. There was little damage to the grounds. The years of planning and preparation helped. I want to thank our fire departments again, Chief Paul Stephans of Hartford Fire and Rescue, Chief Deone Eske of Ashippun Fire, and Chief Terry Kohl of Richfield Fire. Chief Stephans spent countless hours planning, scheduling, and getting other mutual aid departments to help staff the event.

I also wanted to thank Sheriff Dale Schmidt and the Washington County Sheriff's Office. The countless hours the command staff spent in planning and on the grounds ensured a safe and secure event. I also wanted to thank the rest of the department staff including all the deputies. The entire force spent long hours working that week. Many spent long hours working the event. Many others spent long hours covering road shifts throughout the rest of the county, while many deputies staffed the event. They all worked long days and spent a lot of time away from their families and their hard work and dedication was appreciated by the attendees and the residents of the Town.

I am in the process of developing the budget for next year. Tentatively, our costs to the fire departments will be going up. I am also looking at replacing the AED at the Town Hall. Because it is old, it is no longer supported by the manufacturer, has eclipsed its lifespan, and the expensive battery is about due to be replaced.

I will also be replacing the dry hydrant on the Oconomowoc River on Highway Q/County Line Road. It is a hydrant that the town installed back in 2001 in order to pump water from the river for use during fires. Waukesha County has jurisdiction over that section of roadway and is replacing the bridge. The bridge was last updated in 1980 and it dates to 1921, making it the oldest bridge in Waukesha County. It will be completely replaced and redone. As a result, the hydrant will need to be removed, reconstructed and replaced. This construction will take place sometime next year and the bridge will be out, making the road impassible during construction.

Please follow the burning ordinance. We have had several complaints this summer involving burning.

Please be cognizant of conditions before you burn. Your fire **must be attended at all times**. You must be near the fire. You cannot burn during a burning ban. Do not burn if the wind speed is greater than 9 miles per hour. Violations can result in a citation from the Town. The rules for burning are set forth below.

- **No burning permits are required**
- When fire danger is high, very high, or severe, all outdoor burning will be banned (this includes fireworks, which are already restricted by county ordinance) by order of the emergency management director, or town chairman. Outdoor cooking (i.e. grills) is an exemption. For such a ban, I will notify the sheriff's office and local radio stations. Notices will also be found on the town posting boards, and on the website.
- **Open fires must be attended at all times** at any time of year.
- The jurisdictional fire department or preferably the Washington County Sheriff's Office must be notified of any bonfire in excess of 10 feet in diameter or if a large area of grass is burned (i.e. over ¼ acre).
- Fires can't be started on the roadway surface and only leaves and grass can be burned in the right-of-way.
- **The burning of garbage, plastics, rubber, treated wood, petroleum products or anything that emits noxious or toxic odors is PROHIBITED.** The DNR already bans the burning of these items as they pose a health hazard to residents if burned. DNR regulations also prohibit businesses from disposing of solid waste by burning.

Have a safe and happy fall hunting season.

Roads Report by Dan Coffey

As summer passes and we move into the fall, the Erin road crew is starting to get the snow plow (yes I said snow) equipment ready for winter. This doesn't mean that we are done with summer/fall road improvement projects, just that most plow equipment repair has to be done now before the storms arrive. The road crew will also be clearing some brush and tree limbs out of the Right-of-Ways so we have a place to push snow. If you have large trees with limbs hanging in the Right-of-Way, please trim them back. Over the years, a lot of trees were planted too close to the road and need to be cut back or removed.

The roads in the Town of Erin are evaluated every two years using a system called PASER. PASER stands for Pavement Surface Evaluation and Rating. Each segment of road is examined and given a rating from one to ten (ten being new and one being gravel). The results are sent to the State to help track the condition of our roads. Results from the evaluation show that 13.4 miles of our roads need to be rebuilt. I am sure that if you travel some of these roads you would agree. We have 28.5 miles of our roads that can have their life extended by routine maintenance such as crack filling and chip sealing. Chip sealing is the process of applying tar and small stones to the existing road surface. That process costs about 10% of a rebuild. Chip sealing is annoying for the first couple of weeks because of the loose stones but can extend the life of the road from 20 years to 30 or more years so it is very cost effective. The remaining 13.4 miles of the roads have recently been rebuilt and need very little repair.

The Town of Erin receives about \$2,200 per mile from the State and we have about 56 miles of road. This gives us a budget from the State of \$123,200 per year or enough to rebuild 1/3 to 1/2 mile per year. This puts road rebuilding on a 112 year rebuild cycle, far beyond the 25-30 year life of a road. The Town of Erin residents also contribute to the roads budget each year and we usually can rebuild 1-2 miles per year. If your road is in poor condition, we will do our best to keep it patched and will put it on the list to rebuild when money is available.

The new Wisconsin state highway budget was just

passed. It appears that local road money will be the same or less than it has been in the past. Wisconsin borrows a lot of money to repair the roads so more than \$.21 / dollar is spent on interest payment. This means a tight road budget for all and much of the repairs will be done with local money.

Erin School District, by Kieth A. Kriewaldt, District Administrator



This year we had a very smooth start to the school year for our 379 students. There is so much information to share. Here are just a few items.

This year we have seen a small spike in our enrollment. Talking with new families it appears homes in the district are starting to turn over. It appears many of the people buying the homes have younger children and are enrolling the children in our school. We are also having a high interest from families outside the district through open enrollment. The school board has placed limits on the number of students who we can accept so we are able to keep the class size between 18 and 22.

The staff has stayed consistent this school year. We added a part time speech teacher and will be adding a special education teacher in January. Many staff members have continued their training over the summer in both reading and math.

The building and grounds committee continues to meet and confer to keep your school property in top shape and energy efficient. Last year, we completed many projects to include a replacement of all the conventional lighting to LED lighting. This upgrade saved the district \$7,731 a year in electricity and \$8,234 in annual operational. We also received \$4,913 in energy rebates to help offset the cost of the overall project. The project should pay for itself in 6.22 years. After this time, the district will reap the saving.

The district is starting to look into doing other

energy efficiency projects. The big one on the radar is the heating system. We are currently working with a firm to help us map out steps over the next year so we can improve the energy efficiency of our heating system along with other possible projects such as the building envelope overall. Our plan is to present something to the school board by next September and then start getting vendors lined up to do any possible work the summer of 2019. We are not racing into these projects but making sure what we do is the right project at the best price.

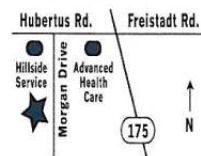

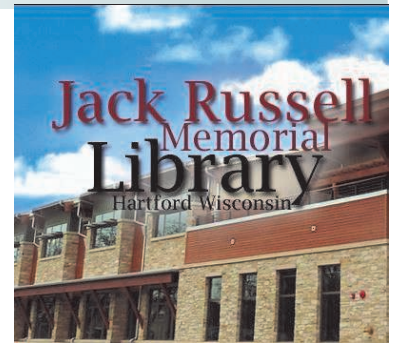


Jack Russell Memorial Library

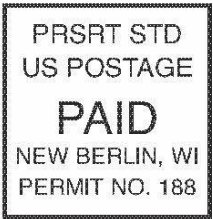
