Elections

The General Election is November 8, 2016. The in-person absentee voting will take place October 3, 2016 to November 4, 2016. The hours will be Monday – Thursday 8:00 am to 4:00 pm. The only Friday for in person absentee voting will be November 4, 2016 from 12:00 pm. to 5:00 pm. Voters are still required to **show their Photo ID** for in-person absentee or Election Day voting. If a ballot is to be mailed out to the voter, the clerk must have a copy of the Photo ID attached to the written request that is submitted to the clerk.

Polling hours on Election Day are 7:00 am. to 8:00 pm. The polls will be the busiest early in the morning so if you are planning to come in before work, please allow enough time to wait. Again, the voter is required to show their Photo ID.

Budget time and Tax reminders

The Town is currently working on the budget for the year 2017. Tax bills will not be mailed out until approximately December 15, 2016. Please refer to the article entitled “Property Tax 101” in the *Erin Township Newsletter* from the fall of 2015, which explains the lengthy process of budgeting and setting up for the tax season.

Tax payments: Remember your first tax payment is due on or before January 31st of each year and made out to the **Town of Erin**. Any tax payment check mailed after January 31st should be written out to **Washington County Treasurer** and mailed or delivered to the County Treasurer at 432 E. Washington Street, West Bend, WI 53095.

IMPORTANT: Tax Bill Changes

The Town of Erin Treasurer wants you to be aware of what is changing this year. Tax receipts are sent out to the owner only if they include a stamped, self-addressed envelope mailed in with the tax payment. If you pay the first half of

your tax bill by January 31, there will be no reminder notices of the 2nd installment payment mailed to the homeowner. The owner must remember to send in the second payment to the Washington County Treasurer on or before July 31, 2017.

Dog licenses

When you receive your tax bill in December each year, please note the form for dog licenses on the back of the tax letter. You may copy this if needed as one form per dog must be filled out. Dogs are required to be licensed by March 31st each year.

Town Hall Rental

Don't forget the town hall can be rented on the weekends for parties, family get together or small weddings. The rental cost for a resident of Erin is \$150 for all day plus a \$100 deposit. The other rental option is \$55 for 4 hours plus a \$55 deposit. The renter is responsible for setting up, cleaning up, and any damages to the hall. The hall can hold up to 165 people with tables and chairs. There are 20 banquet tables and 150 folding chairs. The rental form is on the erintownship.com website under forms. Call 262-673-3682 for questions or to see if a rental date is open.

Chairman Report by Dennis Kenealy

This has been a busy time in preparation for the U.S. Open. There have been numerous meetings to move the event forward. The Town is now turning its attention to our annual budget process which starts in September. I do not foresee any unusual expenses at this time. The Town Board, in conjunction with the Towns Association, is investigating the possibility of high speed internet service. The Town is discussing this with other interested Towns. We are also working with the Towns Association to try to increase maintenance of our highways. We as a Town are limited as to how much money is available for highways. We are trying to find additional moneys to complete more of the work every year.

Plan Commission by Dennis Kenealy

The Plan Commission is reviewing some aspects of the Permit for the U.S. Open, however, the Zoning Administrator is the person who will be working on the issuance of the permit. The Plan Commission and Town Board are reviewing some aspects of the planning process and issuance of permits to make the effort clearer to all. We have an appeal of a Plan Commission decision thus we will be spending more of the budget than anticipated. In the future, we will rely more on our contracted Zoning Administrator so our zoning budget may see some necessary adjustments.

Emergency Government by Brad Bautz

Planning is well underway for the US Open for this upcoming June of 2017. The dates of the tournament will be June 12th-18th. The practice rounds are June 12th-14th, and the tournament is the 15th-18th.

Erin Hills has applied for the special event permit required by the Town. I have been working with town staff on those approvals. The Washington County Sheriff's Office will be the lead law enforcement agency at the event. A number of other agencies will assist with the security. The planning for that is well under way as well. The Wisconsin State Patrol will provide traffic control. *Nothing has yet been set in stone as far as routes and road closures.* We will keep you informed of anything that would affect your daily commute. We will also provide information later on "resident passes" that will be provided so you can navigate to and from your home past the traffic checkpoints. The Wisconsin DOT and the USGA are working to finalize routes of travel. I expect a large use of shuttle buses to and from Erin Hills from sites outside of the Town of Erin.

Please be cognizant of conditions before you burn. Your fire **must be attended at all times**. You must be near the fire. You cannot burn during a burning ban. Do not burn if the wind speed is greater than 9 miles per hour. Violations can result in a citation from the Town. The rules for burning are set forth as follows:

- No burning permits are required
- When fire danger is high, very high, or severe, all outdoor burning will be banned (this includes fireworks, which are already restricted by county ordinance) by order of the Emergency Management Director, or Town Chairman. Outdoor cooking (i.e. grills) is an exemption. For such a ban, I will notify the sheriff's office and local radio stations. Notices will also be found on the town posting boards, and on the website.
- At any time of year:
 - Open fires must be attended at all times
 - The jurisdictional fire department or preferably the Washington County Sheriff's Office must be notified of any bonfire in excess of 10 ft. in diameter or if a large area of grass is burned (i.e. 1/4 acre or more).
 - Fires can't be started on the roadway surface and only leaves and grass can be burned in the right-of-way.



- The burning of garbage, plastics, rubber, treated wood, petroleum products or anything that emits noxious or toxic odors is **PROHIBITED**. The DNR already bans the burning of these items as they pose a health hazard to residents if burned.

Have a safe and happy fall hunting season.

Roads Report by Dan Coffey

This year's road projects included chip sealing eight and a half miles of town roads. The chip sealed roads included all or parts of Roosevelt Road, Druid Lake Road, Galway Road, Powder Hill Road, St. Patrick Lane, Dublin Road, Donegal Road, and Killarney Road. A portion of Donegal Road was also resurfaced. Due to budget constraints we were not able to do the complete section. We will be crack filling (the guys with the tar and toilet paper) some

roads yet this fall.

The road crew is finishing the shouldering on Donegal and will continue mowing the road right-of-ways this fall. We mow the right-of-way at least once a year to keep brush from becoming permanent and to keep the weeds from acquiring snow. It also establishes a vision area to help avoid animal collisions. (A right-of-way area is the road shoulder measured thirty three feet from the center of the road.)

Snow Plow Season

Snow is coming. Please be advised that the only item in the road right-of-way should be your mailbox. All road right-of-ways should be open so plows can push back the snow and not cause damage to the plows.

Christmas Trees

The town will again accept Christmas trees after the Holidays, January 2 to January 20, 2017. A sign will be set up in the back of the parking lot as to where residents can place them. This is for Christmas trees only, not wreaths. This is for drop off only, we do not pick up.

Brush

The brush pit that is normally open on the 2nd Saturday of each month, will not be open between December and March for the winter season.

This year we had a very smooth start to the school year for our 379 students. There is so much information to share. Here are just a few items.



- Erin School District is getting a new playground for the 4K – 5th grade students. This project was made available through the hard work and generous financial support of the Erin Parent – Teacher Club (PTC). The PTC is continuing their fund raiser to add some additional swings and pay off the new addition.

The new equipment was installed the last week of September and followed up with the completion of the accessible walkway and installation of wood chips. The playground is accessible to the community during daylight hours when school is not in session.

- A big thank you to all the people who help daily to make our school run smoothly. This year, Erin Hills Golf Course again donated their facility and course for our 3rd Annual Fun Run/Walk. We thank Erin Hills for accommodating us for this wonderful event. Thank you all who attended the event and supported our PTC and athletics program.
- Over the summer months, Erin staff members worked diligently to review, revise, and renew curriculum in the core academic areas. Many

teachers attended workshops in the area of reading, writing, math, science, and social studies. In June, Erin School District and Richfield School District collaborated to host a three-day training session for 60+ teachers from various school districts. Erin School also hosted UW-Oshkosh to present a master's level math program. With this continued training, Erin School District is preparing our students to be successful for their high school experience and beyond. While the students just enjoyed a relaxing summer break, the learning did not end for the staff.

- The building and grounds committee continues to meet and confer to keep your school property in top shape and energy efficient. Last year, we completed many projects to include a replacement of all the conventional lighting to LED lighting. This upgrade is projected to save the district around \$7,000 a year in electricity and \$1,500 in annual operational. We also received \$4,913 in energy rebates to help offset the cost of the overall project.

Curriculum, by Joannie Kalina, Director of Curriculum & Instruction

The 2016-2017 school year is already full of excitement for Erin students. Be a Superhero; Activate your Leadership Powers is our theme for this year. Students are exploring ways to be everyday heroes and to celebrate their "super powers" by showing leadership. This year, middle school students will also participate in service projects at school and within the community.

Erin teachers activated their learning throughout the summer. Our teachers spent over 160 days collectively growing professionally this summer. We hosted our 2nd annual Reader's and Writer's Workshop Institute for over 70 area educators. Many teachers also spent time growing their skills set in Number Sense, Technology Innovation, Positive Behavior Strategies, Growth Mindset and more. We are grateful for the hard work and dedication of our teachers.

Getting healthy and staying active continues to be priority at Erin. Thanks to our PTC, our middle school recently installed a new Ga Ga Ball pit that the students are thoroughly enjoying! Our Fuel Up to Play 60 team won several amazing awards, including a national video contest, and a Wisconsin Brain Break contest. The team has worked to promote healthy living at Erin School and in the community, through many activities such as fitness nights, nutrition lessons they taught to other students, and creating brain breaks for the classrooms. Two of our students participated in a 4-day leadership training at Purdue University over the summer. Courtney Kirley was elected as a state ambassador and while at Purdue, she was awarded a \$2,000.00 grant for a school garden. We are very proud of Courtney and our entire Fuel Up to Play 60 team. Keep up the great work of promoting healthy lives!

Heating bills a struggle? Applying for the Wisconsin Home Energy Plus program is the answer!

The WHEAP program runs from October 1, 2016 – May 15, 2017. The program offers a one time payment per household, per heating season to assist with your utility cost.

All applicants must meet the income eligibility limits. Example, the income limit for a single person is \$2,181 per month. The income limit for a couple is \$2,852 per month. The size of the benefit will depend on household size, income and heating costs. Assistance is available whether you heat your home with wood, fuel oil, propane, natural gas or electricity. The payment generally is sent directly to the energy provider.

The WHEAP program also partners with the Weatherization Program and may be able to provide assistance if your furnace should break down during the season. This is a program available to you at NO cost. The Weatherization Program will also offer an evaluation of your home to help you reduce your energy costs. If you chose to participate in the Weatherization Program, a representative from Weatherization will contact you to do an audit of your home. Once the audit is complete, you may be eligible for assistance in the form of air sealing, insulating and repair/replacement of mechanicals such as water heaters, furnaces and ventilation fans.

Energy Assistance appointments will be offered in West Bend, Germantown, Hartford and Jackson.

St. Patrick Preservation elections were held on May 10, 2016. The results: President/Secretary – Maureen Fitzsimmons-Vanden Heuvel, Vice President – Robert Schwengel, and Co-Treasurers – Margaret Van Beckum and Joan Coffey. The Board of Directors also includes Wilhelm and Joyce Weber.

Pat Nickols, who oversees the family trust for the care and preservation of Old St. Patrick's Cemetery visited on July 9, before her annual meeting at St. Kilian's. It is always wonderful to see her, along with her granddaughter and daughter-in-law.

The Old St. Patrick Cemetery Walk-A-Round Meeting was held on August 9, 2016. The committee has committed \$7,500 for repairs this year. A total of 20 headstones were identified and marked for repairs. Three on the list have been bypassed in previous years due to the high cost to repair but will be given priority this year. The intent is then to repair the maximum number of headstones with the remaining designated funds.



Our annual membership renewal drive was completed in July but it is never too late to become a St. Patrick Preservation Member. 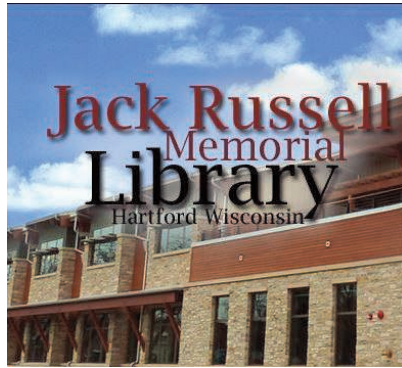

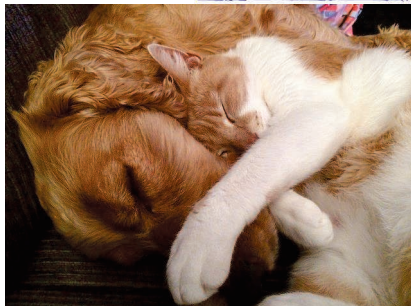

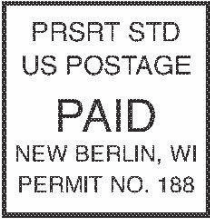
