#### ARTICLE I

#### Traffic Regulations [Adopted 6-15-1998 by Ord. No. 98-10] [Amended on 4/17/2018 by Ord. No. 2018-01] [Amended 9/17/2018 by Ord. No. 2018-04]

#### § 340-1. State traffic laws adopted. <sup>1</sup>

Except as otherwise specifically provided in this chapter, the statutory provisions in Chs. 340 to 350, Wis. Stats., Ch. 23.33, Ch. 23.335, and § 941.01. Wis. Stats., describing and defining regulations with respect to vehicles and traffic, ATV's, UTV's, Off Road Motorcycles, and Snowmobiles, are hereby adopted and by reference made a part of this Code as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this section. Any future amendments, revisions or modifications of these statutes incorporated herein are intended to be made part of this article in order to secure uniform statewide regulation of traffic on the highways, streets, and alleys of the State of Wisconsin.

#### § 340-2. Speed limits.

## § 340-3. Traffic controls; stop intersections.

- A. Intent. It is the intent of this section to promote the health and well-being of users of Town roads by regulating the intersections of such Town roads in the Town of Erin, Washington County, Wisconsin, with traffic control devices. This section is created pursuant to authority granted in § 349.07, Wis. Stats., and other applicable law.
- B. Stopping required on certain roads. No person, driving as an operator of a motor vehicle, at the below noted described Town highway line areas where stop signs have been installed by the Town of Erin to designate these line areas, shall fail as an operator to stop the motor vehicle immediately before crossing such line at such intersection. The line areas designated for official "stop" signs are:

## § 340-4. Traffic controls; yield intersections.

- A. Intent. It is the intent of this section to promote the health and well-being of users of Town roads by regulating the intersections of such Town roads in the Town of Erin, Washington County, Wisconsin, with traffic control devices. This section is created pursuant to authority granted in § 349.07, Wis. Stats., and other applicable law.
- B. Yield to the right of way required on certain roads. No person, driving as an operator of a motor vehicle, at the below noted described Town highway line areas where yield signs have been installed by the Town of Erin to designate these line areas, shall fail as an operator to yield to oncoming traffic before

proceeding. The areas designated for official "yield" signs are:

Limerick Court North end where it intersects with South Limerick Lane

#### ARTICLE III Parking [Adopted 9-19-2005 by Ord. No. 05-09]

## § 340-11. State parking regulations adopted.

Unless otherwise prohibited by state law, the statutory provisions describing and defining regulations with respect to parking and traffic are hereby adopted and by reference made a part of this article as if fully set forth herein:

## § 340-12. Parking prohibited.

No owner or operator of any vehicle shall park, stop, or leave standing a motor vehicle or trailer in violation of traffic regulations or signs in any of the following areas:

- A. Within an intersection.
- B. Upon any portion of a highway in the Town of Erin where and at a time when stopping or standing is prohibited by official traffic signs.
- C. Within any Town park other than in designated areas.
- D. Snow emergency. Whenever the Director of Emergency Management or Town Chair, by reason of heavy snowstorm or blizzard, proclaims a snow emergency, no person shall park, stop, or leave standing any vehicle upon any Town of Erin public roads or any portions of roads during the hours of such proclamation.
- E. Private property. When a sign indicating "no parking" is clearly posted on private property, no person shall park a motor vehicle thereon without written permission of the owner or lessee. This includes private roads.

- F. Within 20 feet of a driveway entrance to any government building.
- G. The Town may create temporary no parking areas. This becomes effective upon proper posting of the area.

## § 340-13. Parking in certain areas prohibited.

No person, unless authorized by the Director of Emergency Management in writing, driving as an operator of a motor vehicle, shall stop, park, or leave standing a motor vehicle at the below noted areas, where the Town of Erin has installed "no parking" signs to designate these areas. These areas are designated for official "no parking" signs:

- A. Dry hydrants (within 50 feet of):
  - Hydrant located on Druid Lake Road at the Ashippun River. NE 1/4 of SW 1/4 of Section 6 Town 9N Range 18E.
  - (2) Hydrant located on STH 167 west of CTH K. SE 1/4 of NW 1/4 of Section 15 Town 9N Range 18E.
  - (3) Hydrant located on CTH Q at the Oconomowoc River. SW 1/4 of SW 1/4 of Section 35 Town 9N Range 18E.
- B. Underground water tanks (within 50 feet of):
  - Tank located on Roosevelt Road at Erin Road. NW 1/4 of NW 1/4 of Section 30 Town 9N Range 18E.

## § 340-14. Parking on certain roads prohibited.

No person, unless authorized by the Town in writing, driving as an operator of a motor vehicle, shall stop, park, or leave standing a motor vehicle at the below noted areas, where the Town of Erin has installed "no parking" signs to designate these areas. These areas are designated for official "no parking" signs:

A. Year-round restrictions. Parking is prohibited on the following roads at all times.

B. Winter parking restrictions effective November 1 through April 1. Parking is prohibited on the following roads from November 1 through April 1 of the following year.

C. Temporary restrictions to be in effect from March 15 through March 19 of each year during St. Patrick's Parade. Parking is prohibited on the following roads:

## § 340-15. Applicability.

- A. The provisions of this article shall apply to all public roads in the Town of Erin.
- B. Any authorized Town official is empowered to enforce this article.
- C. Municipal vehicles and/or officials in performance of duties are exempt from the provisions of this article.
- D. Bona fide utility vehicles are also exempt.

#### § 340-16. Removal of illegally parked vehicles; violations and penalties.

A. Whenever any Town or county law enforcement officer or official authorized to enforce this article has reason to believe that a vehicle is in violation of any provision of the Town ordinances, or of any laws or regulations of the State of Wisconsin, or is creating congestion or is obstructing traffic, he is authorized to require the owner or operator of said vehicle, if able to be found, to move the vehicle to a position not creating a public nuisance. Where the owner cannot be located or is not able to safely move said vehicle, the officer may issue a citation and then have the vehicle towed to a storage lot. Nothing in this section shall prohibit the issuance of a citation to an unlawfully parked or standing vehicle where the vehicle is not towed away. The vehicle shall not be released to the owner of said vehicle until a release from the Town is obtained, which release will be issued upon payment of the citation or the posting of a bond. The owner will further satisfy any mechanic's lien rights which the Town or the towing company may have prior to obtaining the return of said vehicle.

- B. Penalty. The forfeiture shall be paid to the Clerk, Town of Erin, within 7 days of the issuance of a citation. Payments not made within 7 days but before 45 days shall incur an additional forfeiture of \$25. The Town may ask WIS DOT to suspend and refuse vehicle registration for unpaid fines, greater than 45 days, in addition to a forfeiture of \$50. The Town of Erin may also assess the Administrative costs for this.
  - (1) Any person violating § 340-12 of this article shall be required to forfeit not less than \$25 nor more than \$35 for the first offense and not less than \$55 nor more than \$100 for the second or subsequent violations within a year.
  - (2) Any person violating § 340-13 of this article shall be required to forfeit not less than \$60 nor more than \$90 for the first offense and not less than \$100 nor more than \$150 for the second or subsequent violations within a year.

## § 340-17. Prosecution.

- A. Policy. It is the declared policy of this Town that ownership of a vehicle is sufficiently related to causing, allowing or permitting a vehicle to be parked so as to require the owner to be responsible for the parking of said vehicle.
- B. Responsibility. The person or other legal entity to which a vehicle is registered on the date of a parking ordinance shall be chargeable with said violation.
- C. Presumption. It shall be presumed, upon a showing by the Town, that a parking violation occurred, and upon a showing that the party charged pursuant to this article was the registered owner of the unlawfully parked vehicle on the date of the violation, that said registered owner is responsible for and guilty of the violation charged.
- D. Overcoming presumption. The presumption in Subsection C, when established as therein specified, shall constitute a prima facie case and a basis for judgment, except where the person or other legal entity to which the vehicle is registered overcomes said presumption by the submission of proof of any of the following:
  - (1) The vehicle was stolen at the time the violation occurred and reported as such to law enforcement authorities within a reasonable time thereafter.
  - (2) The vehicle was lawfully parked.
  - (3) The ownership of the vehicle was lawfully transferred to another prior to the violation.

- (4) The owner held a lawfully assigned permit to park in a restricted area.
- E. Limitation. This article does not prohibit the actual operator of the vehicle responsible for the parking violation to be prosecuted for said violation. However, where the owner is charged, no other charges shall be brought against another, pending the outcome of said action, and the conviction of the owner shall bar further prosecutions for the same offense.

#### § 340-18. Severability Clause.

Should any section or provision of this ordinance be declared by a court of competent jurisdiction to be invalid, that decision shall not affect the validity of the ordinance as a whole or any part thereof, other than the part so declared to be invalid.

#### § 340-19. Effective Date.

This ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.

#### § 340-20. Violations and penalties; enforcement.

- A. Wisconsin State Rules of the Road Penalties noted found in §§ 346 Wis. Stats., are adopted by reference.
- B. Any person who violates, or refuses to comply with this chapter, shall be subject to forfeiture of not less than \$10, and shall be responsible for all costs and expenses incurred in prosecution. In default of the payment thereof, said person shall be imprisoned in the County Jail of Washington County for a period not to exceed nine months or until such fine and subsequent costs have been paid.
- C. Any authorized Town official or his/her designee is empowered to enforce this chapter.
