Chairman's Update by Dennis Kenealy

I would like to welcome the re-opening of two of our Town's oldest businesses, The Downslope Pub and JC's Corner (formerly Tally Ho). The Town benefits from these businesses in the social aspect and commercial tax base.

The Hi-speed internet construction is in winter pause but will resume with the spring weather. All indications are that the internet will be available to the Town during this year.

A project for this year will be negotiating a new fire and rescue contract with the city of Hartford. The current agreement will be expiring soon, necessitating this action.

Due to the passing of the recent roads referendum, the Town has more funds for road construction this year and the results should be increased road work during 2023.

We recently received notice that Washington County's 980 Committee has selected a site in Erin (NW corner of CTH E and CTH K) for construction and placement of a sex offender. This is a State and County decision. As a Town, we are asking for more information and facts as well as the opportunity for input. We are monitoring this as best we can; the County is the main source of any information.

Zoning Department by Eric Casetta

Whether it is for fresh eggs or just to keep the grass manicured, more and more people are looking to have livestock on their property. There are rules for what livestock can be kept and the number of animals, and it is primarily based on the size of the property. The details can be found in Chapter 360-6 and 360-15, but the quick answer is this: if you have less than 5 acres, you can only have chickens and only hens (no roosters). The number varies based on acreage. If you have more than 5 acres but less than 35 acres, you can keep other livestock as defined in Chapter 360-6 which explains what livestock and how many.

For details on the topic, you can find Chapter 360 on the Town of Erin website at <u>erintownship.com</u>. At the bottom of the homepage, there is a link labeled *Erin Codes*. You can also call the Town Hall and ask for zoning; we are always happy to help.

Roads Department by Road Commissioner and Town Supervisor Dan Coffey

Due to the warm weather and lack of snow, it has been an unusual winter. We have not plowed much snow or salted as often as a typical year. The downside of the warm weather is the freeze/thaw cycles that damage our roads and their foundations. An example is Terry Road between Druid Lake Road and Hwy County O. You really have to hang on if you go over 25 mph. This year is far from over and we can only wait and see what nature has in-store for

Ash tree removal has been done for 2022. Each year we remove 500 to 1,000 ash trees from the right-of-way on our town roads. This avoids dangerous falling trees in wind or storms. If a tree falls and blocks the road during unscheduled work hours, we have to call in the roads crew to address it. We are getting close to completing ash tree removal for all the roads in the Town of Erin but we do have several roads that are waiting for ash tree removal.

The 2022 road projects included rebuilding St. Augustine Road between Hogsback and Elmwood, rebuilding Belfast Lane, Belfast East and West, and repaving Erin Mountain Pass cul-de-sac and Erin Mountain Court cul-de-sac.

The 2023 road repair season is coming. We have \$200,000 from the referendum and we pulled about \$267,000 from Town of Erin savings. If you combine \$370,093.25 allocated from the 2023 budget, add \$267,000 from savings plus \$200,000.00 from the referendum we have about \$837,093.25 to spend on road rebuild and maintenance. This will definitely have an impact on the amount of repair we can accomplish. Thanks to everyone for supporting the referendum.

Our new plow truck is on order. The delivery date is somewhere in 2024 or 2025 due to material issues in that industry. We continue to maintain the current fleet. Unfortunately, we are on the end of the duty cycle for two of our trucks and are spending more time, money, and labor than we would like. Thankfully our roads crew is very talented at repair.

Treasurer's Report by Marjorie Bruha, Treasurer

<u>January 2022 through December 2022</u> Revenue: \$1,482,456 (101.1% of budget) Expenditures: \$1,526,903 (110.2% of budget)

How is a mill rate determined?

In simplest terms, the mill rate is the total amount of the tax levy divided by the total local assessed value for the taxing jurisdiction. For example, Washington County's 2023 fiscal year levy is \$1,549,885.31. Divide this by the Town of Erin total Assessed Value of Property. This amount is \$608,763,218. The county mill rate is 0.00254598 (\$1,549,885.31 / \$608,763,218 = 0.00254598). Add to this, the Town of Erin mill rate of 0.001787486 (\$1,088,156 / \$608,763,218 = 0.001787486), and the school mill rates that

apply to your property location. The schools that apply to your property are listed on your tax bills. The sum of each jurisdiction's mill rate is your tax rate. Multiply your total tax rate by your assessed value and this is your taxes before credits.

What is a financial audit and why does the Town of Erin do one each year?

Wisconsin statute \$60.43(2) requires towns that have a combined clerk/treasurer position to be audited. In Erin, where the clerk is appointed and the Treasurer is elected, the audit is at the discretion of the board per Wisconsin statute \$66.0605. This audit is currently provided to Erin by the public accounting firm Hawkins|Ash, CPAs. Each year they prepare the financial statements of the Town of Erin based on their detailed review of the annual financial activity of the town. This in-depth review by the auditors involves the auditor looking at all financial transactions during the prior financial year. They receive an electronic copy of the accounting software, and copies of insurance, employee records, budgets, bank statements, delinquent property taxes, statement of taxes, employee retirement fund, and employee payroll reports. They also assist the

clerk with any year-end reporting adjustments to the financial records that are required by Generally Accepted Accounting Standard rules. Following this complete analysis, Hawkins Ash will prepare and submit the Audited Financial Statement and the Summary Financial Report to the board each February. This process assures Erin taxpayers that there is a sufficient separation of duties and proper checks-and-balances are in place. It also assures the board that finances are evaluated and determined to be without material misstatement or error.

As I write this article, the town has not declared a "snow emergency" this winter. Just a reminder, if the Town

Chairman or I declare one, that means no vehicles may be left parked on or along the roadway of any townmaintained roads. This is done during larger total snowfall amounts. As a matter of practice during any snow event, please do not park vehicles on or along the state, county, or town roadways.

There have been some instances of parked vehicles interfering with snow removal. If a vehicle goes in the ditch, it should be removed right away. Vehicles must be removed by a licensed towing service for the safety of all. A "snow emergency" does not allow for snowmobiles, ATVs, UTVs or any other vehicles to use the roadways. All state DNR regulations still apply. There are no designated "snowmobile routes" or "ATV/UTV routes" on any roads in the town. ATVs and UTVs, golf carts, etc. are still not allowed to be operated on the roadways.

I do maintain a social media presence for the town with the Facebook page, "Town of Erin, Wisconsin-Emergency Management". On this page are press releases, burning restrictions, road construction closures, and general reminders that can be communicated to residents.

Fire/Rescue Services

The town's intermunicipal agreement with the City of Hartford runs through 2024, (including fire protection). We will need to meet with the city in the future to review the agreement.

Burning

Please follow the burning ordinance. We have had several complaints last year involving burning. Please be cognizant of conditions before you burn. It can be especially dangerous during the spring after the snow melts before everything "greens up". In November of 2020, there was a large grass fire off Erin Road that necessitated the evacuation of some homes in the area, and 14 fire departments responded to extinguish the fire.

Your fire must be attended at all times. You must be near the fire. You cannot burn during a burning ban. Do not burn if the wind speed is greater than 12 miles per hour. Violations can result in a citation from the town. The rules for burning are set forth below.

- No burning permits are required.
- When fire danger is high, very high, or severe, all outdoor burning will be banned (this includes fireworks, which are already restricted by county ordinance) by order of the emergency management director or town chairman. Outdoor cooking (i.e., grills) is an exception. For such a ban I will notify the

sheriff's office and local radio stations. Notices will also be found on the town posting boards and on the website.

At any time of year:

- Open fires must be attended at all times
- The jurisdictional fire department or preferably the Washington County Sheriff's Office must be notified of any bonfire in excess of 10 feet in diameter or if a large area of grass is burned (i.e., over 1/4 acre).
- Fires cannot be started on the roadway surface and only leaves and grass can be burned in the right-of-way.
- The burning of garbage, plastics, rubber, treated wood, petroleum products or anything that emits noxious or toxic odors is PROHIBITED. The DNR already bans the burning of these items as they pose a health hazard to residents if burned.
- DNR regulations also prohibit businesses from disposing of solid waste by burning.







of 2021. Her memory will forever live on, and as one of her dear friends so eloquently remarked, "Dance with the angels, Marge!"






